

Terms and Conditions Agreement between User and artinthedarkpaint.com

Welcome to artinthedarkpaint.com. The artinthedarkpaint.com website (the "Site") is comprised of various web pages operated by Art In The Dark Paint ("AITDP"). artinthedarkpaint.com is offered to you conditioned on your acceptance without modification of the terms, conditions, and notices contained herein (the "Terms"). Your use of artinthedarkpaint.com constitutes your agreement to all such Terms. AITDP sells tickets to uninstructed/freelance painting events which include an unlimited wine bar & music while you paint. AITDP limits each booked session to 6 participants per session.
